Position of the course

This course is an elective seminar course in the Master of Arts in African Languages and Cultures and an elective seminar course in the Master of Science in Conflict and Development. The objectives are: to provide critical insight into contemporary political and social dynamics and contextual determinants of conflict and its societal impact in Central and Eastern Africa through an historical and thematic approach.

Contents

The course approaches current moments and events of contestation, conflict and resistance in Central and Eastern Africa from an historical and thematic perspective. The course, which is a reading course, will explore origins, manifestations and larger impact of resistance, conflict and violence. The course includes, besides of a historical analysis of state formation processes, a detailed reading of specific themes, including the role of identity, political meaning of popular culture, urban protest, armed groups, conflict as social condition and informal processes of regulation.

The issues and case studies may vary depending on current events and ongoing research of

the department.

Initial competences

- All students of the Master in Political Sciences: International Politics, Master in Conflict and Development, the Master in African Languages and Cultures, the Master in History, the Master in Philosophy, the Master in Moral Sciences, the Master in Sociology and the Master in Geography can take this course.
- No specific prior knowledge is required.

Final competences

- 1 Advanced knowledge of, and insight into, the historical state formation process in Central and Eastern Africa.
- 2 Insight in actual processes of contestation and conflict and their social impact, including the political, economic, social, regional and cultural aspects
- 3 Insight into contextual determinants of conflict and resistance.
- 4 Competence in the development of a research agenda.
- 5 Knowledge into the current critical and decolonised thinking on conflict and society in Central and Eastern Africa
- 6 Apply and assess theories from the fields of anthropology, sociology and politicology as part of the study of current dynamics of conflict and society in Central and Eastern Africa

This course will include seminars.

The assignment takes the form of problem-based learning. Two different assignments will be requested: a critical reading of provided literature to be translated into an essay, and a blog piece. Work students can get specific facilities.

Because of the COVID-19 pandemic, lectures might be adapted to 'blended learning' and be a combination of on campus and online sessions. Seminars will be mainly online.

Calculation of the examination mark
