Position of the course

This course allows students to apply the general theoretical frameworks of the course *Politics* of *Development* to concrete thematic and regional case studies and issues.

Contents

The course is organized around three learning goals: (1) develop the critical capacity of students to collectively and independently compare and assess theories and debates on development, inequality and power; (2) develop the critical capacity of students to collectively and independently apply theories of development, inequality and power to concrete thematic and regional case studies and issues. Students hereby choose one of five thematic modules. The learning goals are achieved by individual readings and collective discussions and presentations of key texts, thinkers, and schools on specific questions of development, inequality and power (3) Present these findings in a coherent paper and oral presentation.

Initial competences

This course cannot be followed as a separate course or an elective; unless the course is explicitly mentioned as a possible elective in your program. Considering the strong integration with the general course 'Politics of Development', this course can only be taken in conjunction with 'Politics of Development' or when 'Politics of Development' is successfully finished.

The course consists of 4 seminars (12 hours, 4 seminars). These seminars are prepared through individual work and guided self-study in which the student receives specific assignments and/or readings to prepare for the seminar. Students also engage in group work independent from the teacher, discussing the texts, writing group and/or individual reports, and presenting/teaching their findings to the class group.

Individual participation will be evaluated during the four seminars. Data and criteria are announced via UFORA.

Second exam opportunities for continuous assessment: A written report can be submitted as a replacement for the continuous assessment.

Calculation of the examination mark

The final mark is based on the following weighting factors: assignments: 50% (10/20); oral exam: 40% (8/20); participation: 10% (2/20).

If there is clearly a different input from different group members, then the final mark per student

The deadlines for assignments must be respected. If not, a mark can be deducted from the total

Students have who eschew one or more parts of the evaluation can no longer pass the course. Final scores will be reduced to the highest non-deliberative quotation (7/20) if the final score would be higher than 7/20. When the student scores less than 10/20 for at least one of the components, he/she can no longer pass the entire course unit. If the total score is a mark of ten or more out of twenty, then this is reduced to the highest failing mark (9/20).
