**Position of the course**

This educational component offers a historical framework and political science explanations for international politics from 1815 until present.

**Contents**

The course offers a thorough overview of the international political history from 1815 until present. It is structured according the rise and fall of world orders in which great powers alternately compete and cooperate. The course offers a robust factual historical framework, in order to enable the social scientist to situate essential historical facts and processes such as the German reunification; the colonization of Congo; state formation in the Middle East and the Palestinian Question; the Vietnam War; the Gorbachev revolution; or the 2003 US invasion into Iraq. In addition, the course offers explanations for major events and developments, such as the causes of conflicts, including the two world wars and the Cold War; imperialism and decolonization; the search for the ideal security architecture from the Concert of Europe to the UN Security Council.

Throughout the classes, we tie in with topical developments: we address the historical roots of current power relations and conflicts; the functioning of international organizations such as NATO and the UN; important themes such as nationalism, the unequal North-South relationship, nuclear arms, humanitarian interventions, consultation mechanisms among great powers, the rise of China and Russia's invasion into Ukraine. Students get acquainted with theoretical concepts such as levels of analysis (incl. the importance of the international system, the state level and the level of individual leaders); the balance of power, multipolarity, bipolarity

and alliances; the security dilemma and arms races; military strategy; proxy wars; red lines; liberal internationalism; the role of institutions, ideology, ethics and perceptions in international politics; globalization.

This course does not constitute a modern and contemporary history.

The focus will be on the international-political aspects (evolution of world order; causes and consequences of wars; international cooperation; Cold War; arms race; imperialism; the structure and institutions of the international political economy and its underlying ideas). The focus is NOT on domestic politics and the local history of developing countries, as these subjects are addressed in other courses at Ghent University. Of course, we recommend reading on these topics as well, as they provide context to the core themes of this course.
