**Position of the course**

The first goal of this course is to familiarize the student with the most important literature in political science. In other words, it is an important training in writing academic papers where the student is often confronted with the question: where can I find the information I need? To this end, it is necessary to learn about the theoretical and applied way of using literature in political-scientific research (searching, processing and referring to literature).

Furthermore, this course deals with the essentials of academic writing. Several elements are discussed:

- How to design a good status questionis?
- How to situate your own research in the wider research field?
- How to compose a good research question?
- How to develop research questions theoretically?

Throughout these phases, the course integrates the responsible use of Generative AI.

The content of the course is applied in several practical exercises. The most important assignment consists of writing a scientific paper on a theme in political science chosen by the student.

Finally, an alumnus lecture and a workshop (with collective reflection) familiarize students with the application of the skills and knowledge of political scientists on the job market.

## Contents

This course consists of a theoretical part and a practical part (including exercises). In the theoretical part, attention is paid to the use of literature in political sciences and the different elements of scientific research. What is the role of literature research in the context of scientific knowledge development? Why is it necessary to use and refer to literature when conducting scientific research? Which factors should be taken into account when trying to arrive at a critical assessment of political-scientific literature? What defines a good research problem and research question? Etc.

In this context, the main types of literature (books, journals, newspapers, databases and catalogues, sources of government institutions, etc.) from the political sciences and their possible repositories (libraries, archives and electronic information carriers) are examined in more detail. We also offer the students an overview of the most important literature in political science, both from the perspective of general politics and from a more domain-specific approach. Lastly, the ethical dimension of academic research is discussed throughout the course (including the responsible use of GAI).

The practical part of the course consists of a number of specific exercises:

- formulating a research question and developing a strategy for the literature review
- conceptualising political concepts
- analysing academic research
- applying the APA reference system

Next to this, students write an academic paper that consists of a research question and a literature review. The selected literature will be discussed per discipline studied in the department of Political Sciences. This way, students can select a specific research topic within their field of interest. The paper will also be assessed and periodically evaluated within that discipline.

Finally, this course involves a few practical classes: a public lecture by an alumnus about worklife as a political scientist, a session on GAI and the APA reference system, and a workshop in which students experience the possible applications of the skills and knowledge of political scientists on the job market. This includes writing a brief reflection report and a collective feedback moment.
